Itai Danovitch is Chairman of the Department of Psychiatry and Behavioral Neurosciences at Cedars-Sinai Medical Center in Los Angeles since 2012, as well as Director of Addiction Psychiatry at Cedars-Sinai since 2008. His clinical practice and research focuses on substance use disorders, as well as the integration of medical and mental health services. Dr. Danovitch is a Distinguished Fellow of the American Society of Addiction Medicine, Fellow of the American Psychiatric Association and past president of the California Society of Addiction Medicine. Ken Berrick is the founder and Chief Executive Officer (CEO) of Seneca Family of Agencies, a nonprofit agency dedicated to providing Unconditional Care to children and families through comprehensive mental health, education, juvenile justice, placement and permanency services. Since its founding in 1985, Seneca has developed innovative programs ranging from Wraparound and Intensive Treatment Foster Care, to integrated mental health services in schools, and a crisis continuum of care for youth and their families. Mr. Berrick is a Governor's Appointee on the California Child Welfare Council, where he cochairs the Behavioral Health Committee, tasked with developing best practice recommendations to guide policy and inform statewide efforts to effectively address the behavioral health needs of children involved in or at risk of involvement in the child welfare system. Mr. Berrick is a two-time former President of the California Alliance of Child and Family Services and serves on numerous policy planning groups in California at both the county and state-level. He is an elected member and Past-President of the Alameda County Board of Education, and Past-President of the California County Boards of Education. In 2014, he was recognized by California Mental Health Advocates for Children and Youth as Advocate of the Year. In 2017, he was a recipient of the James Irvine Foundation Leadership Award. He is co-author of the books, Unconditional Care: Relationship-Based, Behavioral Intervention with Vulnerable Children and Families (Oxford University Press, 2010), and Unconditional Education (Oxford University Press, 2018).

Rikke Addis is the founder of Behavioral Health Evaluation Strategies (BHES), a company focused on helping organizations assess and improve client outcomes, to strengthen communities.

Rikke started her work in behavioral health as a graduate student of cultural anthropology. Focusing on at-risk youth, Rikke applied a social suffering framework to her analysis and combined participant observation and oral history methods to gather stories and observations of suffering among youth in the community. Prior to founding BHES, Rikke oversaw evaluation efforts at communitybased children's behavioral health organizations. While there, Rikke oversaw evaluation of programs and conducted qualitative interviews with youth, caregivers, and service providers to understand effectiveness of services. Rikke also led implementation of agency-wide CQI programs with the goals of decreasing the frequency of physical restraints among youth in a group home setting, and improving functional outcomes across multiple outpatient and community-based programs. In 2014, Rikke joined the California Institute for Behavioral Health Solutions (CIBHS) as a state-wide evaluation consultant. Here, she developed an approach to data-driven practice to assist providers in using real-time outcomes data to monitor and adjust treatment.

Rikke is a certified Feedback-Informed Treatment (FIT) trainer, working with agencies and providers to implement Routine Outcome Monitoring (ROM).

Rikke holds a M.A. in Cultural Anthropology from the University of Copenhagen, a B.A. in Cultural Anthropology and a B.A. in American Studies from the University of California, Santa Cruz (UCSC).

Rikke was born in Denmark and emigrated to the United States in 1994.

Sergio Aguilar-Gaxiola is Professor of Clinical Internal Medicine, School of Medicine, University of California, Davis. He is the Founding Director of the Center for Reducing Health Disparities at UC Davis Health and the Director of the Community Engagement Program of the UCD Clinical Translational Science Center (CTSC). He was recently appointed for a four-year term as a member of the National Advisory Council of the Substance Abuse and Mental Health Administration (SAMHSA)-Center for Mental Health Services (CMHS). He is a national and international expert on health and mental health comorbidities on diverse populations. He has held several World Health Organization (WHO) and Pan American Health Organization (PAHO) advisory board and consulting appointments and is currently a member of the Executive Committee of the World Health Organization (WHO) World Mental Health Survey Consortium (WMH) and its Coordinator for Latin America, overseeing populationbased national/regional surveys in Argentina, Brazil, Colombia

(national and city of Medellin surveys), México and Peru. Dr. Aguilar-Gaxiola's research includes cross-national comparative epidemiologic research on patterns and correlates of chronic health conditions, mental and substance abuse disorders in general population samples. Dr. Aguilar-Gaxiola is the author of over 180 scientific publications and the lead editor of the book Depression in Latinos: Assessment, Treatment, and Prevention and co-editor of the book (in Spanish) "Mental Health Epidemiology in Latin America and the Caribbean" ("Epidemiología de la Salud Mental en Latinoamérica y el Caribe") published by the Pan American Health Organization (PAHO).

Robert H. Brook is professor emeritus of Medicine at UCLA, where he directed the Robert Wood Johnson Clinical Scholars Program for over 4 decades and now serves as Emeritus Director for the UCLA National Clinician Scholars Program. He also holds the Distinguished Chair in Health Care Services at the RAND Corporation, where he previously served for 19 years as vice president and director of RAND Health. He was also a senior principal physician policy researcher at the RAND Corporation and a professor at the Pardee RAND Graduate School. He led the Health and Quality Group on the \$80M Health Insurance Experiment and was co-principal investigator on the Health Services Utilization Study. He was the co-principal investigator on the only national study that has investigated, at a clinical level, how Medicare's prospective payment system affected the quality and outcome of acute hospital care. He was also the co-principal investigator on a joint activity of 12 academic medical centers, the American Medical Association, and RAND, the purpose of which

was to develop appropriateness criteria and parameters for the use of procedures.

Brook is a member of the Institute of Medicine, the American Society for Clinical Investigation, and the American Association of Physicians. Among numerous others, Brook was awarded the 2005 Institute of Medicine's Gustav O. Lienhard Award, cited "as the individual who, more than any other, developed the science of measuring the quality of medical care and focused U.S. policymakers' attention on quality-of-care issues and their implications for the nation's health." Brook received his M.D. and Sc.D. from Johns Hopkins University.

Victor G. Carrión is the John A. Turner, M.D. Professor of Child and Adolescent Psychiatry at Stanford University School of Medicine and Vice-Chair of the Department of Psychiatry and Behavioral Sciences. He directs the Stanford Early Life Stress and Resilience Program. Since joining the faculty at Stanford 25 years ago, Dr. Carrion's research has concentrated in understanding how early life stress, such as traumatic experiences, alter behavior and emotion and the role of brain structure and function in these findings. He has also developed new treatment modalities that are focused and targeted. Dr. Carrion chaired the Mental Health Oversight and Accountability Commission for the State of California and published the main text on the neuroscience of posttraumatic stress in youth, as well as texts on treatment. He has received multiple awards from the American Academy of Child and Adolescent Psychiatry, the American Foundation for Suicide Prevention and the National Institute of Health, among others.
