Peer support is an evidence-based practice for the treatment of those with unmet mental health needs. The use of peer support specialists can reduce rehospitalization rates and inpatient days, increase use of outpatient services, lower overall cost of services, and improve outcomes for people with mental health needs. Almost every other state in the nation has established programs to train and certify peer specialists. SB 803, would add California to that list by requiring the establishment of a certification program for peer providers and provides the structure needed to maximize federal match for peer services under Medi-Cal.
