## Overview of Original INN Plan

#### Need

► To create and sustain transformative strengths-based systems change, Mono County providers need an intensive learning opportunity; however, travel is too far to send all providers to an off-site training and on-site training is too expensive for one tiny county

#### Program Goal

 Contribute to learning and meet local professional development needs by creating a cross-county learning collaborative for behavioral health staff and community partners

#### Solution

- Partner with Alpine and Inyo Counties to create a strengths-based learning collaborative
- Bring instructors from CIBHS to the Eastern Sierra (rotating between the 3 counties) for 9 learning sessions
- Contribute to learning by creating a template for cross-county collaboration, a lessons learned factsheet, and a feasibility checklist

#### Funding & Timeframe

- ► Original: \$259,049 over 24 months
- Extension: Additional \$84,935 over 28 total months



### The Need for INN Extension

- Implementation of the Strengths Model took longer than expected
  - Strengths Model Champions
  - One-on-One Coaching
- Identified need for additional skill development
  - Motivational Interviewing
- Challenges for community partners to travel to trainings in Inyo and Alpine
  - Bring facilitators to Mono for partner training
- This extension will provide a boost to the long-term sustainability of this project



## **Evaluation Components**

#### Status of Existing Evaluation

- Measuring all implementation activities to create a "toolkit" that outlines our learning around:
  - Facilitating cross-county and inter-agency collaboration
  - ► The factors that serve as facilitators or barriers to crosscounty collaboration
  - ► The benefits of such a collaboration in remote, rural environments

#### Additional Learning Questions

- How will community partners benefit from in-person, tailored training?
- Will additional MI training and oneon-one coaching help build staff capacity in Mono County?
  - Additional funding for qualitative evaluation will help answer these learning questions and provide richer data on original learning questions

## The need


- LGBTQ+ Community 3x more likely to experience a mental health condition
- Suicide is the 2nd leading cause of death for LGBTQ+ individuals aged 10-24 and over 40% of Transgender Adults have attempted suicide
- Increased substance abuse, homelessness, social isolation, bullying, harassment, and discrimination
- Historical trauma, shame, and stigma





## Innovation – The Pride Center

- There is no prior model of a coordinated service approach across behavioral health clinical services, psycho-educational and community/social supports and training, including capacity building and resources for the LGBTQ+ community.
- The Pride Center is a formal collaboration of community-based organizations with StarVista as the lead agency





# Accomplishments



- Handout programming and community engagement
- Over 2,500 individuals served through FY17-18
- 1,011 individuals accessed programs on site
  - 15% accessed therapy services
  - o 4% used case management services
- Over two-thirds identify as LGBTQ+
- Most are ages 16-59
- Over half are people of color or multiracial
- 5 in 6 are below County's median household income

# Learning Goals & Evaluation

#1 Does the coordinated service approach improve service delivery?

"In the past when i needed mental health services, i needed to find someone supportive and understanding of what I was feeling...I would have felt much safer [at the Pride Center]."

-Youth participant



#2 Does the Pride Center improve **access** to behavioral health services?

"I've been involved in a lot of LGBTQ organizations... \ focused on a particular issue. \ This [Center] brings it all together."

-Older adult participant

# **Extension Request**

- Added value Extension Goals
  - Strengthen internal and external collaboration efforts.
  - 2. Measure **clinical outcomes** of clients with severe mental illness.
  - 3. Develop a **replicable best practice model** to share statewide and nationally.
- Requesting a two-year extension in the amount of \$1,550,000

Services Contract: \$1,400,000

- \$700,000 for FY 19/20
- \$700,000 for FY 20/21

Evaluation Contract: \$150,000

- \$75,000 for FY 19/20
- \$75,000 for FY 20/21
- Plus rollover \$220,000 of originally approved Innovation budget
