### **Consent Calendar**

#### **Item Goals**

- Six items on the Consent Calendar are county innovation plans. The Commission has authority to review and authorize county innovation spending through June 2026. **The following plans are prior year funding being spent down.**
- Innovation Plan for LA County: Program Improvements for Valued Outpatient Treatment (PIVOT): The county proposes to join Orange County's PIVOT innovation project to prepare for implementation of the Behavioral Health Service Act (BHSA).
- Innovation Plan for Contra Costa County: PIVOT: The county proposes to join Orange County's PIVOT innovation project to prepare for implementation of the BHSA.
- Innovation Plan for Contra Costa County: Psychiatric Advance Directives (PADs) Phase
  2 Multi-County Collaborative: The county proposes to join six other counties in the live testing and evaluation of the use of a digital Psychiatric Advance Directive.
- Innovation Plan for Kern County: Semi-Statewide Electronic Health Record (EHR) Project Phase 2: The county proposes to take advantage of two CalMHSA support components; policy implementation and enhanced data analytics/dashboarding.
- Innovation Plan for Imperial County: EHR Project Phase 2: The county proposes to take advantage of two CalMHSA support components; policy implementation and enhanced data analytics/dashboarding.
- Innovation Plan for Shasta County: Reducing Youth Self-Harm and Suicide Rates: The county proposes to empower stakeholder discussion on suicide prevention, while also providing early intervention knowledge and resources.

## **Behavioral Health Landscape**

• Under the Behavioral Health Services Act (BHSA), the counties will no longer be required to create innovation plans. The Commission will use \$20 million each year

from 2026-2031 for an Innovation Partnership Fund, which will fund innovative behavioral health solutions from government, non-profit, and private groups.

- 5. Innovation Plan for Imperial County: Semi-Statewide Electronic Health Record (EHR) Project Phase 2, up to \$1,006,777.01.
- 6. Innovation Plan for Shasta County: Reducing Youth Self-Harm and Suicide Rates, up to \$1,170,700.00.
