**SUBJECT:** Response to CBH re Community Engagement

Meaningful community engagement is a cornerstone of effective program and policy implementation, and we appreciate you bringing these concerns to our attention, especially as they relate to marginalized communities. CalHHS welcomes opportunities to work collaboratively to ensure individuals across the lifespan can share their lived experience to improve our work and the outcomes we hope to achieve. This document provides an overview of existing community engagement activities at CalHHS and its departments as well as upcoming Behavioral Health Services Act (BHSA) engagement activities.

**Existing Community Engagement Activities:** CalHHS is working to leverage existing bodies to improve both access to timely subject matter expertise as well as to hear directly from individuals who participate in services and have unique perspective on how improvements can be made. For example, the <u>CalHHS</u> <u>Behavioral Health Task Force</u> (BHTF) hosts quarterly meetings and monthly "lunch and learns" on topics that support the planning and implementation of Proposition 1 and behavioral health transformation. The BHTF recently focused on best practices and policies to address the housing needs of priority populations identified in the Behavioral Health Services Act (BHSA) and later this fall the group will focus on substance use disorder services from prevention to long-term recovery.

Other bodies leveraging direct input from individuals with lived experience include:

- CalHHS, in partnership with DHCS leadership, has hosted an informal monthly roundtable to hear directly from peer leaders on critical issues of their choosing including improved implementation and expansion of the Medi-Cal Peer Support Specialist benefit.

**Upcoming BHSA Community Engagement Activities:** There are opportunities and resources to support the BHSA community planning process at the local level as well as identify planning efforts at the state level that the community can engage in, included below.

## DHCS:

- DHCS is hosting a <u>public informational webinar</u> on October 16, from 2-3 pm focused on engaging in the BHSA Community Planning Process.
   During the session, participants will learn how to become involved in the Community Planning Process, how DHCS evaluates meaningful stakeholder engagement in the Integrated Plan, and about resources available to help foster your engagement efforts.
- DHCS has created <u>many helpful resources</u> that we plan to share to the public through our BHTF list serve and make sure people aware of the upcoming October 16<sup>th</sup> webinar.
- DHCS is convening the <u>BHT Quality and Equity Advisory Committee</u> for its eighth meeting of the year on October 21st.
- DHCS contracted with CalMHSA to create <u>best practices planning tools</u> for counties.
- DHCS has produced multiple new informational products to support the community planning process. Here are a few useful examples:

## CDPH:

- CDPH released its <u>BHSA Population-Based Prevention Program Guide-Phase I</u> for public comment in July.
- Later this month, CDPH plans to release its BHSA Population-Based Prevention Program Guide- Phase II for public comment.

## HCAI:



- HCAI convened 21 community engagement sessions as part of its
  Workforce Education and Training (WET) community engagement process
  with over 287 participants to identify the most effective solutions for
  addressing California's behavioral health workforce shortage. HCAI is
  using these community engagements to identify specific recommended
  workforce program proposals.
  - HCAI will provide an overview of the emerging findings of the WET Plan stakeholder sessions at the <u>California Behavioral Health</u> <u>Planning Council; Workforce and Employment Committee</u> on October 15<sup>th</sup> from 1:40pm.
- HCAI has launched a collaborative project exploring targeted investments in pathway programs to diversify and expand California's behavioral health workforce. The Phase 1 report will be delivered on October 10<sup>th</sup>.

In addition, CalHHS and its departments are forging collaborative relationships with Commission for Behavioral Health's staff to support BHSA planning and implementation. At this point, several touchpoints through regularly scheduled meetings are underway. We are fully committed to sharing what we hear and learn in various forums including from within our departments and across agencies to guide, improve and enhance implementation efforts.
