All 4 Youth Overview

- ▶ Partnership with Fresno County Superintendent of Schools & Fresno County Department of Behavioral Health
- ▶ Provide Behavioral Health services to youth ages 0 to 22 years of age
- ▶ Services provided in schools and home
- ▶ Our goal is to ensure ALL students have access to mental health supports in the schools
- ▶ Provide services in all 32 school districts

&
Fresno County Department of Behavioral Health
Partnership

- ▶ 2016 - Planning Phase
- ▶ June 2018 ~ \$111,000,000 contract approved by Board of Supervisors
- ▶ Ramp-up - July 2018 - December 2019
- ▶ Went Live January 2019
- ▶ July 2022 will be year 5
- ▶ Funding: 80% Medi-Cal & 20% Prevention and Early Intervention (PEI)

Our Wellness Centers?

- ▶ Design 36x40 over 1400 square feet
- ▶ Modular Building
- ▶ Large space for Prevention & Wellness engagement activities & Trainings
- ▶ Multi-use space -3 separate treatment rooms with separate outside entrances
- ▶ Separate Restroom/sink
- ▶ 3 Family Partners (staff with lived experience) at each Wellness Center
- ▶ Behavioral Health Clinician
- ▶ Program Supervisors for supervision of staff

Sustainability

- ▶ Fresno County Superintendent of Schools to maintain building
- ▶ Districts to fund Family Partner Prevention & Wellness -AB 114\$, general fund, etc.
- ▶ Certify Family Partners for Peer certification process - Bill Medi-Cal
 - ▶ GED or High school
 - ▶ Lived experience
 - ▶ Attend 80 Hour training
 - ▶ Exam



Successes

- ▶ Over 750 youth receiving services
- ▶ All Wellness Centers open and on proposed timeline
- ▶ Successful grand opening
- ▶ Districts excited and motivated to have these services
- ▶ Family engagement activities have increase
- ▶ Safe place to come visit

Challenges

- ▶ Cost for building materials
- ▶ Stigma around populations served (Homelessness/ LGBTQ/ Foster Youth)
- ▶ Internet connectivity in rural areas - get creative
